The MPIL announces the second workshop of the Max Planck Trialogues of the Law on Peace and War. The workshop will deal with the applicability of international humanitarian law (IHL). The workshop takes a holistic perspective and tackles the applicability in terms of its scope *ratione materiae*, *personae*, and *temporis*. The workshop will also address new forms of conflict such as hybrid war and deal with the applicable legal regimes (IHL & human rights) as well as their overlap and possible conflicts.

The workshop is part of the preparation of the second volume of the Max Planck Trialogues on the Law of Peace and War. The Max Planck Trialogues, published with Cambridge University Press, are a new format of academic publishing in which three scholars co-author a book and tackle one and the same topic of the *ius contra bellum*, *ius in bello*, or *ius post bellum* from their distinct perspectives. The authors are selected so as to represent different theoretical, geographical, and practical backgrounds and each of them contributes a chapter of 80 pages. The crucial idea of the Trialogues is to acknowledge the existing diversity of opinions and approaches in a field and to engage them with each other. Ultimately, the Trialogue shall lead to a book that provides the academic debate with new impulses.

The three authors of the book who will present their draft chapters are: Ziv Bohrer (Bar-Ilan University, Israel), Janina Dill (London School of Economics, UK), Helen Duffy (Leiden University, The Netherlands).

The following commentators have confirmed their participation in the workshop: Orna Ben-Naftali (College of Management and Academic Studies, Israel), Andrew Clapham (Graduate Institute of International and Development Studies, Geneva), Heike Krieger
